## Application Timeline:

- Application deadline is **Friday March 27<sup>th</sup>, 2026 at 5pm.**
- Applications will be reviewed by the Foundation Scholarship Committee who will make the selection of applicants that will move on to in person interviews.
- If selected, applicants will be contacted to schedule a mandatory **IN PERSON** 15 minute interview with the full Scholarship Committee on **Thursday April 23<sup>rd</sup>, 2026**. If applicants cannot attend the interview on this date, we ask that you apply for the next award cycle.
- The Foundation will provide final award status to applicants by email within two weeks after interviews.

## Applicant Considerations:

- Scholarship funding is available for those seeking to work in the Central Ohio real estate industry only.
- Incomplete applications will not be considered.
- The Foundation encourages applicants to research **The Ohio Division of Real Estate** requirements to ensure applicant is eligible.
- Must plan to enroll in stated program within six months OR are already enrolled and will still be in classes when funding is awarded. Unused funds will be returned to the Foundation. **If not enrolling within six months, The Foundation suggests applying for the next scholarship application cycle.**
- If selected, proof of enrollment from the school/program is required. A letter of intent may also be submitted. Any final award amount will be paid on the recipient's behalf **DIRECTLY** to the institution provided. In no case will funds be distributed directly to the recipients. If programming has already been paid by the recipient, reimbursement will be provided by the school/program once scholarship funds have been distributed.
- The Foundation encourages research on the role and structure of Columbus REALTORS®, Ohio REALTORS® and National Association of REALTORS®.
- Content created in whole or part by AI is not permissible.
- Once you are an active member, the Foundation encourages Columbus REALTORS® committee/industry involvement.
- Proper pronunciation is REAL-tor.

## Application Requirements:

1. **Personal Essay:** Tell us about yourself. Why should the committee select you for a scholarship, why would it be a sound investment for the Foundation and real estate industry, and why do you want to be a REALTOR®?
2. **12 Month Business Plan:** Use the below fillable format only: **(Page 2)**. Your qualified plan should present well thought-out goals, evidence of financial stability and take into account initial start up costs.
3. **Typed responses to the following prompts: (Page 3)**
  - What is your educational background (ie high school, college, other educational programming) and did you complete it? If not, why?
  - What is your current and previous employment history? Please include job title, dates, and any applicable reasons for leaving.
  - Please describe any current leadership roles, community involvement, or awards/designations received.
  - Choose **three** words that describe you best **AND** explain in one sentence for each word how each will help you succeed as a REALTOR®.
  - Do you plan to work full time or part time once licensed? Why?
  - Will you be part of a team or solo agent? Why?
  - Have you had any experience or involvement in the real estate industry (ie shadowing, interviewing brokerages, etc.) and/or what steps have you taken to prepare yourself to enter the real estate industry?
4. **Two letters of recommendation:** Appropriate submissions include supervisors, community leaders, colleagues, etc. (non-relatives), and may include Columbus REALTOR® members.
